

Homemakers of Larimer County Guidelines For
The Carmen Johnson 4-H Award



1. The award shall be called The Carmen Johnson 4-H Award.
2. Money for the award is to be deposited by the treasurer.
3. To ensure a continuing project, the principal will remain intact. The following money will be used for the award each year:
 - A. The interest from the principal.
 - B. Fifty cents of every Homemakers of Larimer County=s dues.
 - C. Donations from clubs, The Carmen Johnson Award money-making projects, and memorials.
4. The award is to be used by Larimer County 4-H members in good standing.
 - A. Any 4-H member who needs financial assistance with a 4-H project is eligible.
 - B. The amount of the award is determined by Homemakers of Larimer County members. The Carmen Johnson Award may be given to one or more eligible 4-H members.
5. Money that is specifically designated for the Carmen Johnson 4-H Award will be added to the principal. Should there be no applicants for the Carmen Johnson Award; the earned interest shall be added to the principal.
6. The Carmen Johnson Award recipient(s) shall be selected by the Carmen Johnson Award Chairwoman, the President of Homemakers of Larimer County, and one chosen member from each Homemaker of Larimer County clubs. Ex-officio members, with no vote, are Extension Agents, 4-H Youth Development.
7. The selection committee will meet after the applications are due to be judged and winners announced.
8. The award(s) will be sent to the recipient(s) immediately after the selection or presented at a 4-H function or Homemakers of Larimer County session.
9. The Carmen Johnson Award winner(s) must wait 2 years before they can reapply.
